Rendezvous - Ben

Supernaugh Scholarships

- Received 10 applicants. Numbers and quality of applicants were down this year.
- Met with scholarship committee and have selected 5 scholarship winners. Will make offers soon.

Registration

- Early registration closed on Aug 15th.
- Currently, we have 60 people registered (compared to 110 at this time last year). Most have registered for full conference. Target is 150.
- Still waiting for all board members to register.
- 20 of the speakers haven't registered for conference yet. If only coming to give a presentation, they don't have to register. If they plan on attending any other sessions, hospitality suite, etc, they are required to register.
- Online registration is open through Oct 10th

- No leadership from southeast regional office. RD can't attend, and the communications officer will be on vacation.
- Still waiting to hear back from Director's office.

Training Programs

- Numbers are still low.
- Only have 2 or 3 people signed up for most training programs, and no one has signed up for 2 of the programs.

Service Project/Field Trips

- Service project and walking tour numbers are good. (No cost to ANPR.)
- Bus Tour Only 13 have signed up so far. We need at least 25 people to break even.

Outreach

- Cadence is working on a Rendezvous flyer.
- Erika is reaching out to all members within 500 miles of Asheville. We are working heavily with GRSM and BLRI. 32 parks are within a 4-hour drive of Asheville.
- NPS Employee website and Facebook.
- LE academy at SILVA Giving his students one day to come to Rendezvous.
- Also reached out to FLETC.
- Reached out to 15 universities in Asheville area with history, science, other ranger-related fields of study.

TASK – Promote Rendezvous to friends and colleagues. We need at least 100 people to make Rendezvous viable – ALL.

Miscellaneous

- Board members are needed to staff registration desk and assist exhibitors.
- Ben and Alison will be on site the whole time.
- Katlyn will be on site except for service project and bus trip.

Partnership Opportunity

• Millennial couple sent Wendy a message about ANPR. They had found out about us through Western National Parks Association and checked out our website. The couple gave up their jobs to take a trip to visit all 59 all national park units. Started at TAPR on August 18th. They want to partner with ANPR. Wendy will check to see if they'd be willing to come to Rendezvous. Perhaps we could invite them on the bus tour to learn more about ANPR. Could be a good way to reach out to new audiences. • Thoughts?

- Ben didn't get good concept from their blog about how they would fit into Rendezvous or what they were looking to do.
- O Per Wendy it might be a way to highlight the dedication of rangers, that we created our own organization, might hook up with ANPR members at parks to get insider look. Maybe our website could link to their blog site. They are open to ideas. They're just getting started.
- Per Tom good to know that we sponsor young rangers to come to Rendezvous, outreach to new employees, might be good for our fundraising efforts.
- Per Seth proceed with caution as we don't want to reinforce the idea that there's
 difference between national park designations. Seth looked at their website, and
 they only mention the parks, not rangers. We need to ensure that they get
 accurate and complete information.

- Wendy is willing to communicate more with them. The directorate in Omaha was
 enthusiastic about tapping into these folks. We want to see if there's some way to
 get them interested in the work that rangers do.
- Per Kate There could be a lot of potential if they linked to our site, awareness of
 what it means to be a ranger, career in the NPS, land management workforce flex
 act, tie in work that ANPR has done with that, see great communication
 opportunities there.
- Seth from a fundraising perspective, if we move forward, perhaps we could create a unique discount code, if you learn about ANPR from their website?
- Wendy will explore a few more ideas with them, share via email, go from there, try to find out their itinerary to see if they can come to Rendezvous.

Miscellaneous

- Wendy has been going through some things at work that she can't discuss under threat of administrative action.
- Waiting for clearance to continue to participate as ANPR board member.
- Retirement date is scheduled for December 2016.

Membership - Kate
