#### • Government Affairs:

Represented ANPR on a Zoom call with former House Representatives Dennis Ross (FL) and Donna Edwards (MD); both enthusiastic supporters of our national parks. They are reaching out to a variety of national park support organizations trying to encourage more private investments into our national parks to decrease the infrastructure backlog. Having worked in Congress, both know that federal funding will never be enough to overcome this huge backlog even with the GAOA. They feel the NPS is missing an opportunity by not encouraging these private investments. While this is outside of our normal ANPR mission, I encouraged them to contact the new incoming Director whenever he is confirmed and also NPCA. I also passed on this information to some of my contacts in the Service for follow-up if they chose.
