Greetings from the Association of National Park Rangers (ANPR) Membership Growth Committee! My name is Mark Ruggiero, and I am a member of the board of directors and the chair of the Membership Growth Committee.

I am reaching out to encourage you to renew your ANPR membership which has recently lapsed. As you know, we are in very challenging times right now within the entire National Park System and across all Federal Land Management Agencies, including BLM, FWS, BIA and the USFS. Shortages of personnel, reductions-in-force — as well as policy changes that make little sense — are occurring in our park units across the country. There is much discussion within Congress, the White House, and the Department of Interior, about selling off Park units or transferring them to state oversight. Many employees have been displaced and have had job changes imposed on them which have disrupted their lives and have impacted the parks' natural and cultural resources — and, in myriad ways, the stewardship and management of our national parks.

ANPR is very committed to our parks and employees amidst the tumult brought on by the current administration. We are doing everything we can at the Department level and the Bureau level, including helping displaced NPS employees navigate the confusion that is occurring. We are working with the media and with congressional staff to help them understand how these impacts

are affecting our parks. We are working diligently with a group of partners on these tasks – a cooperative partnership including the National Parks Conservation Association (NPCA), Public Employees for Environmental Responsibility (PEER), and the Coalition to Protect America's National Parks (CPANP).

We want you to remain a part of our team. Would you please renew your membership with us, and remain involved? ANPR needs your support and help – now and in the future – as we strive to remain vigilant to the needs of National Park Service rangers and supporters – across disciplines and across agencies – devoted to conservation of park resources.

Thank you, in advance, for renewing your membership today. And feel free to reply to this email if you would like to give us any suggestions of how we might better serve you.

    - Continued to work with the strategic planning team with NPCA, CPANP and PEER. Issue brief papers are ready for distribution. They have great "talking points" and case examples that will be used for informing the public through the media and informing elected officials. Let me know if you want access to the papers.
    - I have submitted the bi-annual corporation report to the DC Corporation Commission.

  - 2.3\*: Worked with a new contributor for the spring issue of *Ranger* to contribute moving So There I Was that reflects the times. Also, due to the current workplace environment, I have lost our Admin columnist and have been advised that no current working employee would be willing to fill that role.
  - 2.4: Was absent for the June meeting of the RR committee, but completed all duties toward that goal, and filed a report on my activities since our last meeting.
  - 2.6\*: Board reports were included in the Summer issue of Ranger magazine. I would suggest we move board reports deadlines to the end of my production schedule to keep them as current as possible. (i.e. instead of the July 30 submission deadline for other pieces, we move the date to Aug. 15.)
  - 2.8\*: I have forwarded posts to Greta that seem like they might be worth mention in our social media.

- 2.10: I have worked with Brandon Pisani on the development of a trifold he created and communicated with him about RR and other possibilities to be actively engaged with ANPR. Would suggest he is worthy of recognition at RR48 for his time spent developing the trifold.
- Other: Created an account with Flipsnack to create flipbooks of our quarterly magazine. They look great, and the cost is minimal, but the flipbooks are only good for one year. I plan to work with this platform for the next year unless I find something different that will allow us to forever "archive" all magazines in flipbooks style.
