- Senate Committee Moved Bill to Protect National Park Staffing and Funding (July 29)
- o OPM officially sunsets 'five bullets' emails for federal workers (August 5)
- Year Will End With 300,000 Fewer Federal Workers, Trump Official Says (Aug 22)
 - The reduction would be the largest single-year decline in civilian federal employment since World War II.
- Current end date for the hiring freeze is October 15, 2025
- Last administration announced the nomination of NPS director in August. Will see where that goes.

 - o 2.1: Financials show a significant increase in fund balances so far this year.
 - 2.2: No new free memberships have been given in the last month due to job displacements.
 - 2.4: Continued to work with RR48 management team: Excellent program has been developed; there are still some openings for breakout presentations. A number of raffle/auction items have been provided already, with more expected. The deadline for room block reservations is September 19.

 - 2.6: Continue to work with NPCA and CPANP to respond to the actions and decisions of the administration.
 - 2.8: Continue to work with Western Conservation Foundation on media distributions. Participated in a press conference in Tucson on August 17 organized by the Center for Western Priorities.

 - 2.11: Two special funds the Rick Smith International Fund and the Ranger Emergency Relief Fund have grown significantly in the last couple months.
 - Other: The ANPR on-line auction went live on August 16 with 16 items to bid on, We have several other items to add and several others "promised." These will be added periodically to keep the interest focused on the auction going forward. Solicitation of additional items should continue by BOD members and others.
- Business Manager: (*and Ranger Editor)
 - 2.3*: Worked to provide relevant, current information on the state of the NPS in 2025 in the latest issue of Ranger, with articles from new writers, as well as three letters to the editor. Secured Mark Segal as a guest columnist. Will be losing Kevin Moses in the spring of 2026, and need a new LE columnist, and have lost Marin Karraker as an admin columnist. Could use some help finding replacements
 - 2.4: Have attended RR planning meetings and worked to recruit two speakers for the event, Mark Segal and Vincent Santucci. Have also secured four Silent Auction prizes for the online Silent Auction. Also produced and laid out the RR 48 program pages for the magazine.
 - 2.6*: Solicited Board Reports from the board for inclusion in the Fall issue of Ranger. Half of the board, 6 of 12, sent them in.

- 2.8*: Helped develop and launch the new ANPR storefront, located on our website. Have sent Mailchimp announcement of its opening, and encouraging membership, and the public, to make purchases.
- 2.10: I have not been in contact with NPS staff to encourage board involvement, but did ask a retired NPSer if she might be willing to serve.
- Other: Am working with our webmaster to see about options for online streaming of educational programs to be offered by ANPR.

> President Elect:

- Stating again for anyone doing the cruises, you have an opportunity of reaching people and getting the message of the importance of the NPS. Just stressing the importance of this program.
- Dan Wenk is doing a great job supporting NPS. He is doing a great job on a large stage.
- Met with the SD Congressional delegation top staffers along with NPCA regional representatives, park partners and others. It was a good meeting, and we took our opportunity to talk about the impacts of staff reductions, closures of hours, etc.
