2016 World Ranger Conference @ YMCA of the Rockies; Partnering with IRF in developing a 2016 WRC Planning Team...

Stacy: Our planning team will rely heavily on Tony and Deanne for help and information on what it takes to develop a congress. Rebecca Harriett will also be a good fit for the planning team. Tony has ideas for this as well. We need to start planning soon. IRF has sent a memo of understanding but has not signed anything yet. Stacy plans on attending the Tanzania Congress to get first-hand experience on what goes into crafting a congress. Our 2016 congress will dwarf Ranger Rendezvous in scope and context. Need to present at Tanzania what our initial thoughts are on where the next congress will be and what we are planning.

Next steps: First, the board should determine a point person who will be the key connection to IC and the ANPR board. Second, how do we want to organize this? Interested members have sent emails to Tony. We need to develop an ICS team. Stacy plans on contacting Dave Lattimore and asking him to help set up an incident command plan. Third, determine point of contact during negotiation process - possibly Dan Moses. Fourth, location will likely be at the Y at the Rockies. It is close to an international airport and several parks are nearby. It's large and reasonably affordable and available for select time frame in 2016. We should compare it with one other site though.

Stacy also mentioned that we should consider being open to having it earlier in the year. NPS Centennial Meeting will be in Boston this June to discuss centennial activities. We will need to address our targeted goal of having the Congress in the fall. But we will need to be aware of other 2016 programs and activities planned that year.

Rendezvous 2012 Indian Wells (Palm Springs), California Rendezvous Theme - "Enhancing the Green and Gray" - agenda/presenter ideas for activities and programs on workforce diversity and workplace enrichment. Proposed training courses and service project.

Ashley has put together a Rendezvous Committee (many from the board) this year. Wendy - program and finding speakers. Alison - room share/rides. Tod – training. Jamie – on-site coordination. Potential program ideas: how to apply for federal jobs, the process to apply, and career academy. Wendy has been researching other options. Teresa also has some ideas. Jason and Alison are looking into a search and rescue training which will also provide EMS continuing credits. Still waiting for thumbs up from Tod. Contact Ashley with any ideas for potential speakers and projects. Logo idea will be going out to everyone within the next few days.

Possible Extra Activities: Ashley - yoga in the mornings and having a "Fun Run" one morning. Teresa – I need to know activities that will cost extra money. Hotel is eager for us to go ahead and hold rooms so we need to get that process started. Field Trip to Joshua Tree (½ day with same format - eat lunch then project work) might cost money. It would be easier if we know how much up front.

ANPR Oral History Project Update

Stacy: Meeting this month with LuAnn Jones, Rebecca Harriett and John (JT) Townsend to carry forward with the next phase of the pilot project, interview and planning interview sessions at Ranger Rendezvous. Jeremy and Rebecca have participated in training. Alison is also involved in this project. Pilot project is ongoing. Currently developing a panel of potential interviewees. Need to plan on what needs to be purchased/paid for to meet the needs of this project. Rebecca will have a meeting and notify us soon. Initial cost will be met through the Gale Fund. Logistics is an issue – people are scattered throughout the country. Current plan is to establish interview sessions at Ranger Rendezvous with trained personnel.
